

Mastercard Samsung Pay Rebate Promotion

Offer Terms and Conditions

- 1. **Offer**: Mastercard is offering rebates for eligible transactions using an enrolled Mastercard card with a Samsung Pay wallet in Malaysia ("Offer"). The Offer is valid from Malaysian standard time 12.00am on 6th November 2017 to 11.59pm on 31st December 2017 ("Offer Period"), or whilst rebates last. Rebates are subject to limited availability and the offer is subject to the following terms and conditions.
- 2. **Eligible Transactions**: A Mastercard cardholder who has registered for the Mastercard Priceless Specials Malaysia program ("Program") at the URL https://www.specials.mastercard.com.my/ may avail the Offer for transactions (excluding cash withdrawals, advances and/or balance transfers) that are undertaken during the Offer Period using the Mastercard card registered for the Program in the Samsung Pay wallet in Malaysia ("Eligible Transactions").
- 3. **Exclusions**: The Offer is not available for the following persons:
 - a. a Mastercard cardholder whose card is not eligible for provisioning on the Samsung Pay wallet in Malaysia for any reason.
- 4. **Rebates**: Mastercard shall provide the rebates for the number of Eligible Transactions subject to the following conditions:
 - a. each Eligible Transaction must be for a minimum value of Fifteen Malaysia Ringgit (RM 15) only; and
 - b. the maximum amount of rebates available for each Mastercard card registered on the Priceless Specials Malaysia Program is one-hundred and fifty Malaysia Ringgit (RM 150);
 - to avail the maximum rebate of one-hundred and fifty Malaysia Ringgit (RM 150) available under this Offer, a cardholder must undertake a minimum of twenty seven (27) Eligible Transactions during the Offer Period. Applicable rebates shall be calculated and awarded as per the transaction milestones defined in the table below:

- 5. **Payout**: Mastercard shall provide a credit of the rebate amount to the Mastercard card account within 15 days from the date of the applicable Eligible Transaction. Mastercard cardholders will be able to track the number of Eligible Transactions undertaken and the earned rebates from the Program website.
- 6. **Terms**: In addition to the Terms of Use for the Program published on the Program website, the following terms shall apply to the Offer:
 - a. in the event of abuse or fraud in tracking and/or redemption of Eligible Transactions for calculation of rebates, Mastercard may, in its absolute discretion, cancel rebates already issued;
 - b. Mastercard may, in its absolute discretion, modify or terminate this Offer or any portion hereof, or withdraw, cancel or invalidate any rebates already qualified without incurring any liability to any cardholder;
 - c. Mastercard shall not be liable if it is unable to perform its obligations under these Offer Terms, due directly or indirectly to the failure of any machine or communication system, industrial dispute, war, act of God, or anything outside the control of Mastercard or its employees or agents;
 - d. in the event of any inconsistency between these Offer Terms, and the Program Terms of Use, these Offer Terms shall prevail;
 - e. Mastercard's decision on all matters relating to this Offer and the rebates shall be final and binding on the registered Mastercard cardholder;
 - f. Mastercard reserves the right to change, vary or modify these Offer Terms at any time in its sole and absolute discretion and each registered Mastercard cardholder agrees to accept any such changes, variations or modifications;
 - g. these Offer Terms will be governed by the laws of Malaysia. If any of the provisions of these terms and conditions becomes or is invalid, illegal or unenforceable in any respect under applicable law, the validity, legality and enforceability of the remaining provisions shall not in any way be affected or impaired and such invalid, illegal or unenforceable provisions shall be deemed severed from these terms and conditions and Mastercard shall be entitled to replace such severed provisions with such other provisions as it may deem fit.
